ADMISSION GUIDELINES

1. Instructions regarding the admissions to 5 year LL.B and 3 year LL.B., Programmes for the academic year 2026-27.

- The Principal shall verify the promotional eligibility of the students for admission to next semester/ year of the programme.
- The admissions for subsequent years shall be made as per Admission calendar 2026-27 and by enclosing all previous semester marks cards. **Incomplete applications shall be liable to be rejected.**
- The Statement of admission in proforma-1, 3 & 4 shall be submitted to the University at the time of verification of original documents at University.
- The Proforma no: 1, 3 and 4 of consolidated admission statements in A3 size papers shall be bound in a single booklet along with the covering letter (with details of fee paid) & shall be addressed to the Registrar, Karnataka State Law University, Hubballi, and shall be submitted to the University at the time of original document verification.

2) FEES

- Principals are strictly instructed to collect the fees as prescribed by the University from time to time.
- The College shall ensure that the students belonging to SC/ST and OBC community shall apply to concerned District Social Welfare/BCM Department for the scholarship.
- It is informed that if any college has dues of admission fees of previous year then the University will not approve the admission of students of such college for the year 2026-27.

- Consolidated admission statement in Proforma No: 03 along with admission applications with necessary attested documents to be submitted at the time of original documents verification.
- The Proforma No 1 to 4, of admission statements along with the covering letter (with details of fee paid) addressed to the Registrar, Karnataka State Law University, Hubballi, has to submitted at the time of original document verification .
- If proforma contains incomplete information, then such proforma will liable to be rejected and admissions of the students of such college will not be approved or may be withheld for want of information.
- The serial numbers of candidates in subsequent admission statements viz, Proforma 3, shall be in continuation with the 1st list of admission statement.
- Admission statement in proforma - 3 should be prepared as per the date of admission serially, not in alphabetical order.
- Fees collected shall be remitted through online (SBI Collect). The admission statements and the fees paid details shall be submitted to the Registrar, KSLU along with the **Proforma No: 04** containing details of fees.

2) The college/s shall admit the student/s only after verification of the necessary documents & eligibility criteria, as detailed in the University Regulations. ELIGIBILITY CERTIFICATE

- The applicant who has passed the prescribed qualifying examination from recognized University/Boards of examination that are situated outside Karnataka or in a Foreign country shall **compulsorily obtain** the ELIGIBILITY CERTIFICATE through (online) **Seva Sindhu portal** before taking the admission.
1. Candidates may apply to the KSLU for obtaining the Eligibility Certificate. They have to apply through online mode i.e. through Seva Sindhu web portal to the office of K.S.L.U., Hubballi along with original/attested documents of 10th, 12th Std or equivalent qualification as notified by the Government of Karnataka, MHRD, NIOS, from time to time & U.G., Degree marks cards along with the transcripts issued by the concerned University or Board or Department. **If the marks cards issued by the universities are in grade systems (CGPA) then percentage conversion transcript / marks card have to be uploaded in seva sindhu web portal.**

 3. The Eligibility Certificate may be issued online through Seva Sindhu by the University only after the fulfilment of eligibility conditions as laid down in **BCI rules of legal education, 2008**, BCI clarification dated 30.04.2017 and the Government of Karnataka Orders issued from time to time.
 4. The qualifying degree/certificates and marks cards should be in Kannada or English only.
 5. All those candidates who have obtained qualifying degree/certificate from outside the Karnataka state should produce the countersigned original certificates from the issuing authorities/universities, otherwise eligibility will not be considered.
 6. The students who have studied qualifying examination under CBSE, ISC Board's 12th standard examinations are exempted from eligibility certificate for admission.
 7. Fees for Eligibility certificate is as prescribed by the University.

ADMISSION GUIDELINES

1. Instructions to the affiliated Law Colleges regarding the admissions to 3 year Law Programmes for the academic year 2026-27.

The applications for admission and the admission statement should be as per Proforma prescribed by the University. The duly filled in admission statements in **Proforma-1, 2, 3 and 4**, shall be sent to kslu.registrar@gmail.com in MS excel format mandatorily on or before 14th Oct 2026. Admissions shall be made purely on **Merit cum Reservation Basis**.

The eligibility for admission is as given below:

A) 3 year LL.B programme (1st year) :

(a) An applicant who has graduated in any discipline of knowledge from an University established by an Act of Parliament or by a State Legislature or an equivalent national institution recognized as a Deemed to be University or Foreign University recognized as equivalent to the status of an Indian University by an authority competent to declare equivalence, may apply for **Three year degree** programme in law leading to the conferment of LL.B. degree on successful completion of the regular programme conducted as per KSLU Regulations.

(b) **Minimum percentage of marks** in qualifying examination shall not be below 45% (44.5% and above shall be treated as 45%) of total marks in case of General category applicants, 42% (41.5% and above shall be treated as 42%) for Cat-1, 2A,2B,3A,3B category (**Karnataka Students only**) and 40% (39.5% and above shall be treated as 40%) of total marks in case of SC and ST applicants (**Karnataka Students only**).

Note : 1. Students having grade points (CGPA) in the marks card of each semester should submit a Grade to percentage conversion certificate from the concerned school/board/university along with the application.

2. If the Student does not submit Grade to percentage conversion certificate, then such candidate application may be rejected.

(c) **Maximum age *** for seeking admission is limited to 30 yrs (thirty years) in case of General category of applicants and to 35 yrs (thirty five years) in the case of applicants from SC, ST and Other Backward Communities as on **22.09.2026**

Explanation:

An applicant who has passed the 3 years U.G. degree from Open or Deemed University recognized by & established under the UGC Act, after prosecuting the studies in the pattern of 10+2 at Secondary/Higher Secondary Schooling is eligible for admission to 3year LL.B programme.

The applicant who has passed the qualifying examination U.G. degree in a single sitting examination is not eligible for admission to 3 yr Law programme.

** Writ Petition (civil) No. 1023/2016 is pending before the Supreme Court of India regarding the maximum age limit prescribed for admission. The admission of the students who have crossed the age limit is subject to the outcome of the said writ petition. In this regard, college has to obtain an undertaking from the students who have crossed the age limit in the proforma enclosed.*

B) For subsequent year admission

- a) The admissions for subsequent years shall be made as per Admission Time Table of 2026-27 by enclosing all **previous semester marks cards**. **Incomplete applications shall be liable to be rejected.**
- b) The Principal shall verify the promotional eligibility of the students for admission to next class/year of the course.
- c) The Statement of admission in **proforma-1, 2, 3 & 4** shall be submitted to **kslu.registrar@gmail.com**.
- d) The Proforma no: 1 to 4, of consolidated admission statements in A3 size papers shall be bound into a single booklet along with the covering letter (with details of fee paid) & shall be addressed to the Registrar, Karnataka State Law University, Hubballi, and be submitted at the time of original document verification.

2) ADMISSION PROCEDURE

- a) Admission to the programme shall be made strictly on the basis of merit cum reservation basis. While making admission to the course reservation policy of the Government of Karnataka governing admissions to higher educational institutions issued from time to time shall be observed strictly.
- b) The admission of the students has to be on the basis of Merit cum Reservation. The Reservation policy as notified by the Government of Karnataka and Seat Matrix issued by the University has to be adhered to.

3) FEES

- a) All Principals are strictly instructed to collect the fees as prescribed by the University and Government of Karnataka.
- b) The college should see that the students should apply to District Social Welfare/BCM Department concerned for SC/ST/OBC students scholarship.
- c) **All the Principals are strictly instructed that if previous years admission fees have not been remitted to University fully then, present year admissions will not be approved at the time of Admission verification for the year 2026-27.**

4) CASTE CERTIFICATE

- **The caste certificate should be submitted at the time of submitting application for admission and it should be valid as on the date of admission. For Scheduled Caste students the caste certificate should be based on internal reservation policy i.e SC-A, SC-B, SC-C.**

5) INTAKE

- a) No College shall admit the students in excess of the sanctioned intake provided by the University and Bar Council of India.
- b) As per the BCI letter No. BCI:D:468/2024/Cir-006/2024(LE) dated: 25.05.2025 the affiliated colleges may admit students belonging to Economically Weaker Sections (EWS) up to 10% over and above sanctioned intake subject to the conditions stipulated in the said circular. It is relevant to note that the student claiming seat under EWS quota has to submit the EWS certificate issued by the authority concerned and should be valid for the year to which the admission is sought.

6) THE COLLEGE AUTHORITY SHOULD STRICTLY VERIFY -

- a) The eligibility of the students should be as per BCI rules & KSLU admission regulations before admitting the students to the programmes.
- b) The students shall be asked to produce the Migration and Transfer Certificates within fifteen days from the date of admission.
- c) In case of applicants from Foreign Universities/Boards, the applicant should have obtained the valid passport, visa, Residential permit, and "Students Study Permission/NOC" from Foreign Embassies of both the nations. They should also obtain a certificate that the degree is obtained from a recognized Board/University from the embassy concerned in India.
- d) In case of applicants from Foreign Universities/Boards, the applicant shall be asked to produce the "Equivalence Certificate" issued by the Association of Indian Universities (AIU), New Delhi if necessary.
- e) At the time of documents verification by the University for admission approval, the college should submit the originals of above documents & 'Eligibility Certificate' (wherever applicable).
- f) The Principal of the college shall verify the original documents and attest the copies thereof.

- g) The Principal of colleges should certify that the admissions (for all classes) of course/s are made as per the admission rules of Karnataka State Law University, Hubballi and Government of Karnataka.
- h) In case a student is an employee either in State/Central/Private organization, he/she shall submit No Objection Certificate from employer concerned stating that the working hours do not conflict with college timings and the Principal should certify that the candidate is capable of attending 75% of classes.

7) THE COLLEGE AUTHORITIES SHALL ENSURE SUBMISSION OF THE NECESSARY DOCUMENTS BY THE APPLICANT TO THE COLLEGE, AS BELOW.

- a) The Eligibility Certificate issued by the University, in case of Non-Karnataka and Foreign students at the time of admission.
 - b) 10, +2 and U.G. Degree Marks cards of all years/Semesters & Passing certificate in case of **3 year LL.B.** admission at the time of admission
 - c) The Transfer / Migration Certificates shall be submitted by student to the college at the time of admission or within fifteen days from the date of admission to the college.
 - d) In case of SC/ST/Cat-1/OBC student, **Caste & Income certificate** shall be submitted by student to the college at the time of admission if they claim Fee Exemption.
- **Consolidated admission statement in Proforma No: 02 along with admission applications with necessary attested documents to be submitted at the time of original documents verification.**
 - **The Proforma No 1 to 4, of admission statements along with the covering letter (with details of fee paid) addressed to the Registrar, Karnataka State Law University, Hubballi, and be submitted at the time of original document verification .**
 - **Incomplete information in the Proforma will be rejected and admissions of the college will not be approved or may be withheld for want of information.**
 - The serial numbers of candidates in subsequent admission statements viz, Proforma III, shall be in continuation with the 1st list of admission statement.
 - Admission statement in proforma - III should be prepared as per the date of admission serially, not in alphabetical order.
 - Fees collected shall be remitted through online (**SBI Collect**). The admission statements and the fees paid details shall be submitted to the Registrar, KSLU along with the **Proforma No: 04** containing details of fees.

Note:

1) In complicated/doubtful cases, the principal of the college may seek clarification from the Academic Section.

2) The college/s shall admit the student/s only after verification of the necessary documents & eligibility certificate for fulfillment of eligibility criteria, as detailed in the K.S.L.U. Admission rules. In case any college admits in-eligible candidate/s to any course, the Principal will be responsible for further consequences in the matter of non-approval of such admission/s as per the University norms.
